



CONTEST RULES

The Torlonia Collection: Masterpieces of Roman Sculpture

1. Contest Dates

The Contest will be held from Friday, June 26 at 10 a.m. to Sunday, July 19, 2026, at 5 p.m.

The Contest is organized in connection with the exhibition *The Torlonia Collection: Masterpieces of Roman Sculpture*, presented at the Montreal Museum of Fine Arts (the “MMFA”).

2. How to Enter

To enter the contest, simply complete the online entry form at <https://www.mbam.qc.ca/en/a-trip-to-rome-contest/>, between June 26, at 10 a.m. and July 19, 2026, at 5 p.m.

No purchase is necessary to enter. Purchasing a ticket or membership does not automatically enter you into the contest. To be eligible, anyone wishing to enter must complete the form mentioned above. No paper forms will be available on site.

3. Prize Description

One (1) Grand Prize will be awarded that includes the following:



- Two (2) Air Canada Economy Class tickets for a round-trip flight between Montréal-Trudeau Airport (YUL) and Rome Leonardo da Vinci-Fiumicino Airport (FCO), Italy. Value of CA\$ 5,800;.
- A gastronomic experience for two (2) people in Rome, Italy, including a meal with wine pairings, courtesy of wine producer Feudi di San Gregorio. Approximate value of CA\$450;
- Exclusive admission for two (2) to a visit of the Villa Albani Torlonia, the private historic residence of the Torlonia family. Approximate value of CA\$160;
- A copy of the exhibition catalogue for *The Torlonia Collection: Masterpieces of Roman Sculpture*. Value of CA\$49.95;

Trip Dates

The trip must be reserved no later than July 31, 2027 and must be completed by August 31 2027. Under no circumstances may the above-mentioned booking and travel-by dates be extended.

The following travel blackout dates apply: from June 26 to September 7, 2026 inclusively, from December 9, 2026 to January 10, 2027 inclusively, and from June 17 to September 6, 2027 inclusively. The blackout periods are subject to change without notice.

Reservations

Flight reservations, train tickets, and admission to the Villa Albani Torlonia as well as departure and return dates are subject to availability. Once the reservation is confirmed, any changes or cancellations made before or during the trip shall be at the expense of the Grand Prize winner or their travel companion. The Grand Prize winner must make reservations and other trip arrangements in accordance with the instructions received.



All applicable fees, such as airport/departure taxes, security charges or other third-party fees, taxes or charges are included in the promotional tickets. Promotional ticket recipient are responsible for any and all costs, expenses and taxes not expressly described herein including, without limitation, ground transportation, gratuities, merchandise, telephone calls, personal expenses of any nature for overnight layover, meals and beverages, service charges, in-flight meals and entertainment; costs incurred to and from the departure point, obtaining sufficient personal travel insurance prior to departure, if desired; obtaining and carrying all necessary travel documentation, such as passports and visas and complying with customs immigrations regulations.

The MMFA will send the exhibition catalogue to the Grand Prize winner by Canada Post.

General Conditions

The Grand Prize winner and their travel companion must be at least 18 years of age.

- Prize winner understands and acknowledges and will ensure that their travelling companion understands and acknowledges the risks related to the spread of infectious or contagious diseases and understand it remains their responsibility to take the necessary precautions applicable to any health hazards, including but not limited to COVID-19. Prize winner is aware and will

The MMFA makes no representations or warranties, express or implied, regarding the quality or suitability of the Grand Prize awarded as part of this Contest. The Grand Prize winner understands and acknowledges that they cannot claim a refund or



pursue any legal or equitable remedy from the MMFA if the Grand Prize fails to meet its objectives or is deemed unsatisfactory in any way by the Grand Prize winner or their travel companion.

The total approximate value of the Grand Prize is CA\$ 6,459.95. The exact value depends on the trip dates.

The Grand Prize must be accepted as offered. It may not be sold, transferred or monetized, and it will not be reimbursed if not used. No substitution, modification, or extension is permitted. The Contest Sponsor reserves the right, at its sole discretion, to replace the Grand Prize with another prize of equal or greater value or to authorize its transfer.

4. Draw

One (1) draw will take place on Monday, July 27, 2026, at 3 p.m. from among all eligible entries received between Friday, June 26 at 10 a.m. and Sunday, July 19, 2026, at 5 p.m. The Grand Prize winner will be contacted by email or telephone and informed about how to claim their prize.

5. Eligibility



This Contest is open exclusively to legal residents of Quebec who are 18 years of age and older, with the exception of employees, representatives or agents of the MMFA and its affiliates, its promotional or advertising agencies and suppliers of products and services related to the promotion of this Contest, as well as any persons who reside with them.

6. General Conditions

The Grand Prize winner will be chosen by random draw. This person will be contacted by email or telephone at the contact information provided on the entry form, in the seven (7) business days following the date of the draw. Should the selected entrant be unreachable by email or phone, or if this person fails to return the call or email within a period of seven (7) business days from the time they were initially contacted, or is found to be ineligible, they will be disqualified from the Contest and be considered to have forfeited the Grand Prize. The MMFA may then, at its sole discretion, select an alternate winner by random draw.

Before being declared the winner, the person selected for the Grand Prize and their travel companion will be required to sign a declaration and return it by the specified deadline. In this declaration, these parties shall:

- a) Confirm that they have complied with the Contest rules and that they accept the prize as awarded;
- b) Acknowledge that the MMFA, Air Canada and their respective affiliates, promotional and advertising agencies, suppliers of products and services associated with this promotion and representatives are not liable for any incident arising in any way whatsoever from the use of the prize;
- c) Acknowledge that the MMFA, Air Canada and their respective representatives are entitled to use their photos, names and addresses with no compensation other than the prize.
